The meeting was called to order at 7:41pm by SMMHA President, Mark Brintnell.

Attendance was taken for all of those in attendance.

## President's Address: Mark Brintnell – SMMHA President

 Mark B. expressed his thanks to executive members, SMMHA staff, board of directors and players and families for their commitment to the minor hockey program. Mark feels it take a community to run a successful minor hockey program and he has been proud of the community that has been behind SMMH.

## Financial Report: Rich Ballantyne – SMMHA Treasurer

- A detailed financial report was circulated to all individuals in attendance. For those who were unable to attend, the report can be obtained if a request is sent to a member of the executive.
- This was the first full year using QuickBooks as the association's book keeping program, therefore no year to year comparison was provided, but in future years this will be included In the report.
- The 2022-2023 budget was approved as proposing a \$100,000 deficit, due to accumulated surpluses over the past few COVID-affected seasons, as well as changes to referee payment/elimination of gate fees. The end result was a net loss of \$66,915.89
- The new book keeping system and an accurate ability to track referee costs has created a system that will be able to accurately determine costs and make budgeting more precise.
- General Highlights:

- Total income: \$450,599.39 with the majority of this coming from registration fees and tournaments
- Total expenses: \$517,581.22 with the largest contributors being ice rentals (\$\$359,921.29), Referee costs (\$48,255.03) and Insurance Dues (\$27,016.09)
- Associations current total liabilities and equity is equal to \$257,899.79 (recognizing that \$\$29,746.12 of that total belongs to the St.Marys Lincolns lottery account and is therefore not our money.
- **Question:** How much income did gate fees contribute in past years? Up to \$40,000 per season
- **Question:** Are there any other foreseeable increases in costs to the association? At this time, nothing is confirmed, but ice costs generally increase at 1.5% annually. Referee costs will also likely increase at an inflationary cost, as well as the mileage cost.
- Question: Have we discussed alternate ways to minimize the cost of registration increases, to prevent the sport from becoming financially unattainable for families? The association continues to fundraise by running tournaments (4 in 2022-2023 that profited more than \$20,000 in total (NBC tournament financial summary not available at this time). The association would benefit from having a committee create a financial needs plan to ensure the game of hockey in St.Marys does not become out of reach, financially, for families.
- Chris B. motioned to accept the 2022-2023 Financial Report as presented. Seconded by Paul W. Carried.

## **Changes to SMMHA Constitution**

- Katharine F. made the motion to accept the proposed changes to the SMMHA Constitution, as circulated to membership for review on April 22, 2023. Seconded by Paul W.
  - Discussion: Paul W. reminded that any changes to the constitution requires a 2/3<sup>rd</sup> majority vote to pass and must be presented to the membership for review, at least 10 days prior to the vote at the meeting. All proposed motions were emailed as well as posted online on the SMMHA website.
- Motion was Carried

- Katharine F. made the motion to accept the proposed changes to the SMMHA Policy and Procedures Manual, as circulated to membership for review on April 22, 2023. Seconded by Paul W.
  - **Discussion:** Paul W. reminded that any changes to the Policy and Procedures Manual must be approved by a majority vote at any general or AGM meeting. He also suggested to be more accurate, the motion should incorporate any changes in article numbers, due to the deletion or addition of sections.

Katharine was thereby acclaimed as Secretary for the 2023-2024 season.

#### **Election of the Coaches Committee members:**

- Joe Wilhelm motioned to accept Owen Penny and Greg St. Clair as new members to the coaches committee, each for a three year term. Seconded by Paul W.
  - A recommendation report was circulated by Joe, highlighting the qualities and criteria that were assessed in all Coaches Committee applicants.

#### Motion to amend article 18.5 to now read:

The six (6) elected members of the committee are not eligible to apply for a head coaching position with an "A" or  $2_{nd}$  entry rep team.

2. Where as print media is no longer the most effective way to target information regarding upcoming meetings and motions, to the preferred audience.

Where as St. Marys Minor Hockey Association has gained significant following on various social media platforms, by members and adherents.

#### Motion to amend article 24.6 to now read

Notice of the time and place of members' meetings, annual or general, shall be given to each member by publishing said notice on all of the Corporation's social media accounts, at least ten (10) days before the time fixed for the holding of such meeting; provided that any meetings of the members may be held at any time and place without such notice if all members or the Corporation are present thereat or represented by proxy duly appointed, and at such meeting any business may be transacted as the Corporation at annual or general meetings may transact.

Amendments to the By-Laws: Any proposed amendment to the by-laws must be placed on the SMMHA website at least ten days before the membership meeting where the proposed amendment will be discussed

The OMHA representative shall be an appointed position with the responsibility to ensure that all SMMHA teams, players, and officials are properly informed of their commitments involving OMHA regulations. The rep will attend any meetings which affect govern OMHA policy and regulations that affect SMMHA. The rep shall keep SMMHA's best interest in mind while acting on behalf of SMMHA at all meetings. The rep shall be responsible for setting schedules for each team in OMHA play downs

#### Motion to add (1) Player Movement Coordinator position to the list of Assigned Officials

The Player Movement Coordinator shall be an appointed position with the responsibility to ensure that all teams, members, officials, and players are properly registered for each playing season. The rep will communicate with players, their representatives and the association regarding transfers, permission to skate, travel and tournament permits and roster building, ensuring all documentation is completed and uploaded correctly and within required timelines. The individual will work closely with the Registrar, OMHA Rep and coaches committee chair to help facilitate the registration, rostering and placement of players, staff and teams for the annual operations of SMMHA.

## Motion to amend Section 19 – Police Check Policy – to substitute Player Movement Coordinator in place of OMHA rep throughout the entire article.

The Shamrock representative shall be an appointed position with the responsibility to ensure that all A and 2nd entry teams, members, officials, and players are properly informed of their commitments involving Shamrock regulations. The rep shall keep SMMHA's best interest in mind while acting on behalf of SMMHA at all meetings. The rep will coordinate with ice convenor all scheduled times for all games and league play downs
